#### **Fund description**

#### Investment objective and overview

The investment objective of the Fund is to achieve capital gain in US Dollars. The Fund seeks to achieve this objective through investment principally on a worldwide basis (up to 25% of net assets may be in Emerging Markets) in income bearing or accruing securities with fixed principal amounts including government bonds, corporate bonds, junior debt securities, preferred shares, convertible securities and contingent capital notes.

#### Opportunities

The Fund invests in a broadly diversified bond universe and seeks various opportunities for returns. The Fund invests in accordance with a flexible investment strategy with a broad diversification across various bond categories, currencies and

countries. The objective is to identify the potential investments that, in the Investment manager's opinion, are attractive and could generate positive

opportunities for investors.





#### Glossary

Average company-issuer rating: is a forward-looking opinion about an obligor's overall creditworthiness and their capacity and willingness to meet its financial commitments.

Distribution yield: is the estimated annualised distribution percentage for the current financial year based on a snapshot of the portfolio at the calculation date. It is calculated by annualising the sum of the current year-to-date distributed & un-distributed income per share and dividing by the current net asset value per share. Modified duration: a risk indicator that measures the effect of price fluctuations on a bond issue or a portfolio of bond issues.
