Monthly comment:

No significant change as of end of August 2024.

It is worth reminding that the valuation uncertainty which led to the segregation of SP funds remains, and that any valuation therefore remains estimated. Our commitment in carrying out the complete liquidation of the SP funds remains unchanged, as does our intention to treat unitholders equally.

Finally, it should be noted that the management of SP funds has no impact on that of FCP funds.
